
**Term and Conditions:-**

1. He must be a former employees of the Bank.
2. He must have a good knowledge about the Accounts and Audit.
3. The upper age limit is maximum 65 years.
4. Remuneration of Rs.15,000/- ( rupees Fifteen thousand) only per month will be paid.
5. Have to submit medical fitness certificate from a medical officer not below the rank of Asst. Surgeon.
6. Have to furnish Cash security of Rs.25,000/- ( Rupees twenty five thousand) only which will be refunded after completion of engagement period.
7. Will not be entitled to any benefit as applicable to the regular employees of the Bank except monthly remuneration as fixed above and actual Bus fair for tour..
8. The contractual engagement is purely temporary upto two years and may be terminated at any time without any prior intimation / Notice.
9. He will also visit to the Branches of the Bank with official person for the purpose of Internal check and control of the Bank.


